## **Anti-Ragging Policy**

### **Introduction:-**

The college has constituted the Anti-Ragging Committee to design strategies and action plan for curbing the Menace of ragging in the college by adopting array of activities. Anti-Ragging Committee will be the supervisory and advisory committee in preserving a culture of ragging free environment in the college campus. Ragging is strictly prohibited in or outside the college campus.

The institute assures all students a learning environment free of ragging and will take all efforts to prevent ragging and have in place measures to address the complaints if ragging does take place.

### **Objectives:-**

- To aware the students about the dehumanizing effects of ragging, its impact on human life and consequences of involvement in the act of ragging
- To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence
- To promptly and strictly deal with the incidents of ragging brought to our notice
- To prevent and protect the student community from being ragged or indulging in the act of ragging
- To set up a monitoring system comprising of Anti Ragging Squad (ARS) to keep vigilance on campus and off campus situations to eliminate the chances of ragging cases.
- To receive the complaints and resolve them through the ARC
- To initiate legal actions when required considering the intensity of ragging instances in case occur.

### **What Constitutes Ragging?**

Ragging includes any act of abuse, whether physical or mental, targeting another student; whether a new student or a senior, on any ground, including caste, race, colour, religion, ethnicity, gender, sexual orientation, disability, appearance, nationality, regional origins, linguistic identity, place of birth or residence, and economic background.



**Monitoring Mechanism:****1) Anti-ragging Committee:**

Institute has constituted an Anti-ragging Committee which is headed by the Head of the Institution, and consisting of representatives of civil and police administration, local media, Non-Government Organizations involved in youth activities, representatives of teaching faculty members, representatives of parents, representatives of students, non-teaching staff and have a diverse mixture of membership in terms of level as well as gender. The Anti-Ragging Committee ensures compliance with the provisions of UGC mentioned regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.

**2) Anti-Ragging Squad:**

Institute also constitutes a smaller body known as the Anti-Ragging Squad, members of which is nominated by the Head or the Institution. The squad maintains the vigilance, oversight and do patrolling functions and remains mobile, alert and active at all times. The Anti-Ragging Squad has representation of various members from the college staff and has no outside representation. The Anti-Ragging Squad can make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging.

**Functions of Anti-ragging Committee:**

- 1) To consider the complaints received from the students and conduct enquiry and submit report to the Anti-Ragging Committee along with punishment recommended for the offenders
- 2) Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
- 3) Conduct workshops on Anti-ragging and orient the students;
- 4) To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls.
- 5) To create awareness among the students about Anti ragging.
- 6) To take all necessary measures for prevention of Ragging inside the Campus/ Hostels.
- 7) To ensure compliance with the provision of UGC Regulation on Anti-ragging at the institution level.

**Anti-ragging measures:**

The measures to prevent ragging will include:

- 1) Publishing the anti-ragging policy statement on institutional website.
- 2) Organizing workshops and campaigns to aware the students about ragging.

- 3) Undertaking from students and parents accepting the anti-ragging measures.
- 4) Monitoring student behavior to detect ragging, including occasional surprise inspections to prevent ragging.
- 5) Counseling probable offenders and aggrieved students on appropriate behavior.

**Actions to be taken for indulging and abetting ragging in the institute :-**

A strong, commendable and justifiably harsh punishment would be given to the persons indulged in ragging to act as prevention against recurrence of such incidents. The Anti-Ragging Committee of the institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.

Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following: -

- 1) Cancellation of admission.
- 2) Suspension from attending classes.
- 3) With holding/withdrawing scholarship/fellowship and other benefits.
- 4) Debarring from appearing in any test/examination or other evaluation process.
- 5) With holding results.
- 6) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
- 7) Rustication from the institution for period ranging from 1 to 6 semesters.
- 8) Collective punishment when the persons committing or abetting the crime of ragging are not identified, the institution shall have choice to collective punishment to ensure community pressure on the potential ragers.

## **Women Empowerment Cell and Anti-Sexual Harassment Cell**

### **Anti-Sexual Harassment Policy**

#### **1) Objective :-**

Anti-Sexual Harassment Policy is framed to create safe work environment and to protect dignity of Women Employees as envisaged by Supreme Court of India Guidelines on Sexual Harassment, August 1997 and "The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013".

The Policy intends to ensure that no woman Employee is subjected to sexual harassment at workplace. "Women Employee" as referred to in this Policy includes all women employees of Arts, Commerce and Science College, Alkuti, whether permanent or temporary, probationary, or part-time.

#### **2) Definition: -**

- 1) "Act" means "The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013" and any amendment thereto.
- 2) "Aggrieved Woman" means any female Employee of Arts, Commerce and Science College, Alkuti or any woman who alleges to have been subjected to any act of Sexual Harassment at the Workplace.
- 3) "Anti-Sexual Harassment Committee" means a committee by that name, constituted by Arts, Commerce and Science College, Alkuti as per the provisions of the Act.
- 4) "Respondent" means the person against whom the allegation of Sexual Harassment has made by the Aggrieved Women".
- 5) "Sexual harassment" means and includes: -
  - a) " Unwelcome behavior of a male employee towards a female employee (whether directly or by implication) as:
    - i. Physical contact and advances
    - ii. A demand or request for sexual favors

- iii. Sexually coloured remarks
  - iv. Showing pornography
  - v. Any other unwelcome physical, verbal or non-verbal conduct of sexual nature."
- b) Implied or explicit promise of preferential treatment to a woman employee in her employment; or
  - c) Implied or explicit threat of detrimental treatment to a woman employee in her employment; or
  - d) Implied or explicit threat to a woman employee about her present or future employment status ; or
  - e) Interference with her work or creating an intimidating or offensive or hostile work environment for her; or
  - f) Humiliating treatment likely to affect her health or safety.

3) **Anti-Sexual Harassment Committee: -**

The Committee shall comprise of:

- A Presiding Officer who shall be a woman employed at a senior level at workplace from amongst the Employees.
- Not less than 2 (two) members from amongst Employees preferably committed to the cause of women or who have had experience in social work or have legal knowledge; and
- One member from amongst non-governmental organization or associations committed to the case of woman or a person familiar with the issues relating to sexual harassment.

4) **The Anti-Sexual Harassment Committee will operate on the following guidelines :-**

- a) The person against whom the allegation of Sexual Harassment has been made by the Aggrieved Woman Complaints Committee shall meet as and when any instance of violation of the policy is referred to the committee and, in any case, at least once in a year.
- b) The Anti-Sexual Harassment Committee shall prepare the annual report submit the report pertaining to number of cases filed and their disposal under the act to the Board.

- c) The Presiding Officer and the members of the Anti-Sexual Harassment Committee will hold the position up to five years from the date of their nomination.

**5) Functioning of a Committee: -**

**A) Lodging a Complaint**

- The Aggrieved Woman makes a complaint directly to the Presiding Officer of the Anti-Sexual Harassment Committee. The Presiding Officer should be able to try & solve the grievance informally before escalating the matter to the formal Committee within a period of one month from the date of incident.
- Where an Aggrieved Woman is unable to make a complaint on account of her physical or mental incapacity or death or otherwise, her legal heir or such other person as may be prescribed may make a complaint.

**B) Conciliation**

Anti-Sexual Harassment Committee may, before initiating an inquiry, at the request of the complainant take steps to settle the matter between her and the Respondent through conciliation. However, no monetary settlement shall be made the basis of the conciliation. Where a settlement has been arrived at as mentioned above, the Anti-Sexual Harassment Committee shall record the settlement so arrived at and forward the same to the management of Arts, Commerce and Science College, Alkuti to take action as specified in the recommendation and shall provide copies of the settlement to the complainant and the respondent.

**C) Inquiry into Complaint**

Anti-Sexual Harassment Committee shall proceed to make inquiry into the complaint in accordance with the provisions of the service rules applicable. Such an inquiry (with due conciliation as appropriate) shall be completed within a period of one month. Confidentiality of the complaint procedure will be maintained.

Anti-Sexual Harassment Committee shall proceed to make an inquiry into the complaint in accordance with the principles of natural justice and further during inquiry provide an opportunity of being heard to the complainant and the Respondent and the relevant witnesses provided by the complainant and the Respondent.

**D) Inquiry Report**

On the completion of such inquiry, the committee shall provide the report of its findings to the management of Arts, Commerce and Science College, Alkuti within a

period of 10 days from the date of completion of enquiry and such report be made available to the concerned parties. The management of Arts, Commerce and Science College shall act upon the recommendation within 20 days of its receipt.

If Anti-Sexual Harassment Committee arrives at the conclusion that there is no case for Sexual Harassment, then the committee shall notify the same to the management.

**6) Penalties to Respondent:-**

If the sexual harassment complaint is proved prima-facie right to the Committee based on the material and/or witness verified by them, then the Committee will recommend to the Management to the Respondent in terms of

- Warning in writing
- Immediate suspension from the services
- Immediate termination
- May immediately refer the case based on the gravity and merits of the case to the local police/judicially.

**7) Punishment for False Complaint:-**

Where the Anti-Sexual Harassment Committee arrives at a conclusion during or after the inquiry that the allegation against the Respondent is either malicious or false, appropriate punitive action may be taken by the Management as per service rules applicable on recommendations of the committee.

**8) Confidentiality:-**

Notwithstanding anything contained in the Right to Information Act, 2005, contents of the complaint, the identity and addresses of the Aggrieved Woman, Respondent and witnesses, any information relating to conciliation and inquiry proceedings, recommendations of the Anti-Sexual Harassment Committee and the action taken by Arts, Commerce and Science College, Alkuti shall not be published, communicated or made known to the public, press and proceedings media in any manner.



**9) The Management Assurance: -**

- Express prohibition of sexual harassment will be notified and circulated.
- Prohibition of sexual harassment is included in the Service and Conduct rules of the company.
- As far as possible, care is taken to see that lady colleagues if sitting very late i.e. beyond 9.30 p.m. for official work, are escorted home or some arrangements are made for them to reach home safely.
- Complainants or witnesses will not be victimized or discriminated against while dealing with complaint

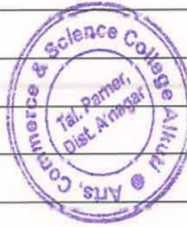
